The Autism Diagnostic Observation Schedule

East Lothian and Midlothian

Information for parents and carers

This is an information sheet about the Autism Diagnostic Observation Schedule (ADOS) which is a specialised assessment that can assist in the diagnosis of Autism Spectrum Disorders (ASD). It can be used across a very wide age group.

What is the ADOS?

The ADOS is carried out by specially trained clinicians, and in Lothian these might include Paediatricians, Speech and Language Therapists, Occupational Therapists, Clinical Psychologists and Child Psychiatrists.

The ADOS is suitable for all age groups but is tailored for an individual child or young person's language level. It explores their development in some key areas of interest for the diagnosis of an Autism Spectrum Disorder, such as the ability to share attention and communication, aspects of play and imaginary thought and the way that communication is used.

Who carries out the ADOS?

The assessment is undertaken by two of these professionals, one of whom videos the assessment for the later analysis. The ADOS takes from 45 minutes to about 1 hour to conduct, and a lot of this depends on the needs of the child or young person themselves and the pace that best suits them.

Do I have to fill in any forms?

We will ask you to sign a consent form for the ADOS to be recorded and we will seek assent/consent from the young person themselves if that is appropriate. On this form we will also ask you to let us know if your child is on a special diet as we may use some food items in the earlier modules.

Where will parents/ carers be during the ADOS?

We may or may not ask you to stay with your child during the ADOS, as this depends on the module level that is being used and this in turn depends on the child/young person's language development.

If we need you to stay with your child during the ADOS then it is usually very difficult to accommodate siblings. We therefore ask that you do not bring them along to the ADOS if at all possible. We would need you to stay if your child had either no speech or single words/phrase speech only. If you are uncertain about whether you will need to stay in the room and you are having difficulty finding care for any other children, then please contact us before the appointment.

What will happen during the ADOS?

Please note that the ADOS assessment requires that both the clinician and the child remove their face masks/coverings once the assessment begins, in order to facilitate communication and enable assessment of social communication skills. Everyone will still be required to wear face masks/coverings in the waiting room and corridors. To reduce risk, there will be a 'pop up' Perspex screen on the table as a barrier to potential droplet transmission for the duration of the assessment, and your child will be required to sanitise their hands at regular intervals throughout the session (as will the clinician).

The clinician will also maintain 2 metre physical distancing as much as possible, and the room will be well ventilated, so please ensure your child is dressed accordingly. This has been approved through our risk assessment procedures.

To the observer the ADOS looks like a series of interesting scenarios appropriate to the child or young person's level of development, e.g. forms of play such as bubbles for young children, through to making up a story dialogue for a video by older children.

When will we know the outcome?

Following the ADOS, the clinicians will analyse and score the assessment and consider all of the assessment information that has been collected to date. This will take them around 90 minutes (during this time you are free to leave the building). We will give you a time to come back later that morning/afternoon so that we can feedback the outcome of the complete ASD assessment. Your child is welcome to return with you for the feedback but does not need to – we will leave it up to you to decide what is best for you and your child.

Please put aside the full morning or afternoon for the assessment and feedback.

If there is anything further you would like to ask about the ADOS before signing the consent form please feel free to ask us.

Keeping your appointment

If you cannot keep your appointment, or have been given one that is unsuitable, please change it by phoning the number on your appointment letter. Your call will give someone else the chance to be seen and will help us keep waiting times to a minimum.
