Medication supply requirement	<ul> <li>Check what medication is available on the downstream ward prior to transfer</li> <li>For medicines that are needed, supply at least enough to last 7 days.</li> <li>Check the medication to be supplied against the long stay prescription chart or HEPMA</li> <li>Pre-pack labels do not have to be filled out.</li> <li>Ward stock or unlabelled supply issued from pharmacy may be sent with the patient if it will not be available at the community hospital (except controlled drugs e.g. not gabapentin or pregabalin).</li> <li>If a 7 day supply is not available at the point of transfer, do not delay transfer but liaise with the downstream ward to ensure a supply can be obtained or delivered to avoid the patient missing any doses.</li> </ul>			Supply at least 7 days supply of medication in the form the patient will need it at home  Original packs / pre packs if independent  Dosette if pharmacy-filled dosette required at home  MAR chart if for discharge to care home or level 3 medication support with MAR chart in community	14 day supply	14 day supply	Check if the care home has a supply of existing medicines. Controlled Drugs	*Check if downstream ward has the CD in stock or if they would be able to order it in time for the patient's arrival, if not, liaise with pharmacy as an IDL will be needed to allow CDs to be supplied. Buprenorphine patches must be supplied.

<sup>\*</sup>Discharge letter required if controlled drugs need to be supplied. ACP medicines and oxycodone liquid / lower strength tablets not usually supplied.
